## TERMS AND CONDITIONS

This is the contractual part; please fill in all the blanks and be sure to read carefully.

1. \_\_\_\_\_ (“Client”) hires and authorizes Whoa Doggy!, LLC (“Whoa Doggy!”) to perform pet care services as outlined in this contract through use of Whoa Doggy’s employees or contractors (“Pet Sitter”).
2. The parties herein agree as follows: The initial term of this contract shall be from \_\_\_\_\_ through \_\_\_\_\_

3. In the event of early return home, client must notify Whoa Doggy! at least 24 hours prior to the next scheduled visit to avoid being charged for unnecessary visits(s).
4. The baseline fee is \$\_\_\_\_\_ (service fee per visit) x \_\_\_\_\_ (number of visits) for a total of \$\_\_\_\_\_. Other fees for additional services or circumstances may apply. Any additional visits made or services performed shall be paid for at the agreed contract rate. Whoa Doggy! is authorized to perform care and services as outlined on this contract. Whoa Doggy! is also authorized by Client to seek emergency veterinary care with release from all liabilities related to transportation, treatment, and expense.
5. Should specified veterinarian be unavailable, Whoa Doggy! is authorized to approve medical and/or emergency treatment (excluding euthanasia) as recommended by a veterinarian. Client agrees to reimburse Whoa Doggy! for expenses incurred, plus any additional fees for attending to this need or any expenses incurred for any other home/food/supplies needed.
6. In the event of inclement weather or natural disaster, Whoa Doggy! is entrusted to use best judgment in caring for pet(s) and home. Whoa Doggy! will be held harmless for consequences related to such decisions.
7. Whoa Doggy! agrees to provide the services stated in this contract in a reliable, caring and trustworthy manner. In consideration of these services and as an express condition thereof, the client expressly waives and relinquishes any and all claims against Whoa Doggy! except those arising from gross negligence or willful misconduct on the part of Whoa Doggy!.
8. Client understands this contract also serves as an invoice and takes full responsibility for PROMPT payment of fees upon completion of services contracted. A finance charge of 10% per month will be added to unpaid balances after thirty (30) days. A handling fee (\$35) will be charged on all returned checks. One half deposit is required on lengthy assignments and first time clients, or clients with a history of late payment and will be required in advance before services are rendered. In the event it is necessary to initiate collection proceedings on the account, Client will be responsible for all attorney's fees and costs of collection.
9. In the event of personal emergency or illness of scheduled Pet Sitter, Client authorizes Whoa Doggy! to arrange for another qualified person to fulfill responsibilities as set forth in this contract. Client will be notified in such a case.
10. All pets are to be currently vaccinated. Should Pet Sitter be bitten or otherwise exposed to any disease or ailment received from Client's animal which has not been properly and currently vaccinated, it will be the client's responsibility to pay all costs and damages incurred by the victim.
11. Whoa Doggy! reserves the right to terminate this contract at any time before or during its term. If Whoa Doggy!, in its sole discretion, determines that Client's pet poses a danger to health or safety of Pet Sitter, or if concerns prohibit Pet Sitter from caring for pet, Client authorizes pet to be placed in a kennel, with all charges there from to be charged to client.
12. Client authorizes this signed contract to be valid approval for future services of any purpose provided by this contract permitting Whoa Doggy!

to accept telephone reservations for service and enter premises without additional signed contracts or written authorization.

PLEASE NOTE: The utmost care will be given in watching both your pet(s) and your home. However, due to the extreme unpredictability of animals, we cannot accept responsibility for any mishaps (including, but not limited to biting, furniture damage, accidental death, etc.) or any complications in administering medications to the animal. Nor can we be liable for injury, disappearance, death or legal fees associated with pet(s) with access to the outdoors.
